### DSPs Do San Francisco

Get your fill of digital signal processing at the **DSP<sup>x</sup>** exhibition and symposium at San Francisco's Moscone Center. The conference, which runs June 13–15, has three tracks. An introductory track consists of tutorials and workshops. A second track features moderated panels discussing specific products, while the third focuses on applications and case studies.
