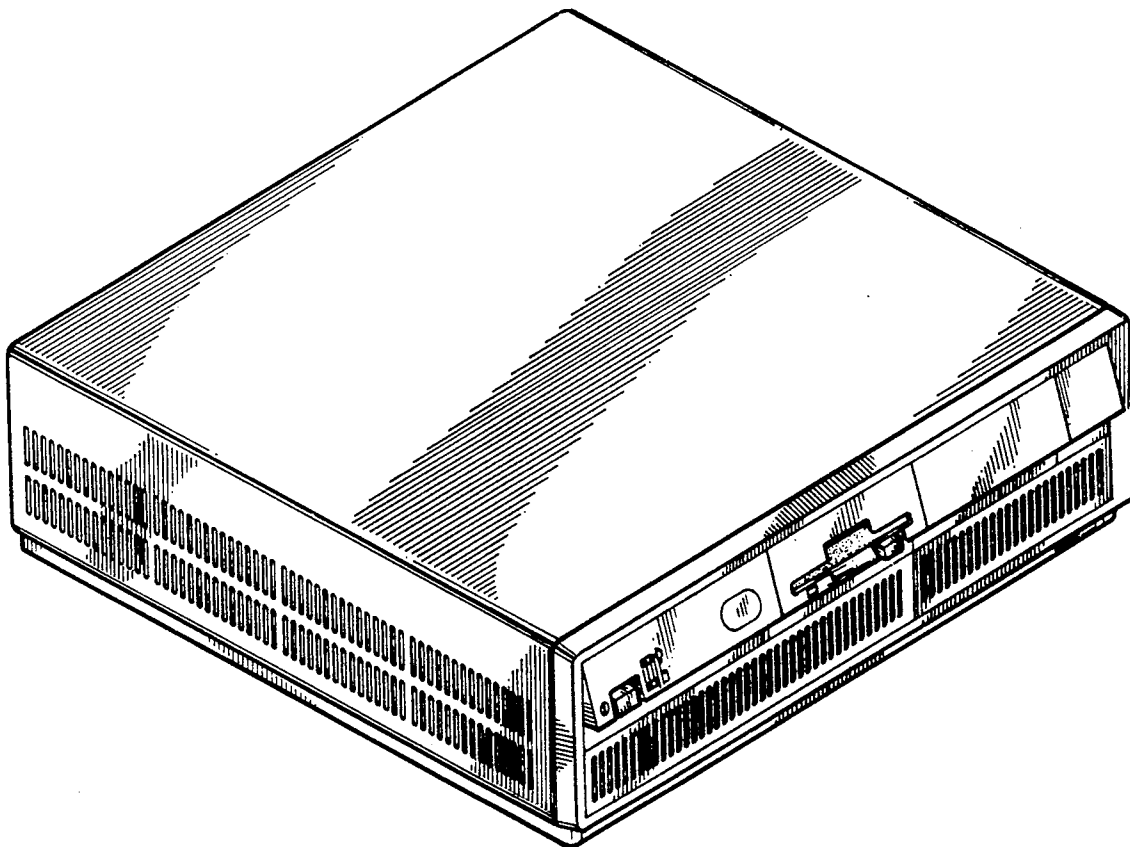

[57] **CLAIM**

The ornamental design for a personal computer enclosure, as shown and described.

DESCRIPTION

FIG. 1 is a left, top, front perspective view of the personal computer enclosure showing our new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a right, top, front perspective view thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a top plan view thereof. FIGS. 2-4 and 6 are drawn on an enlarged scale.



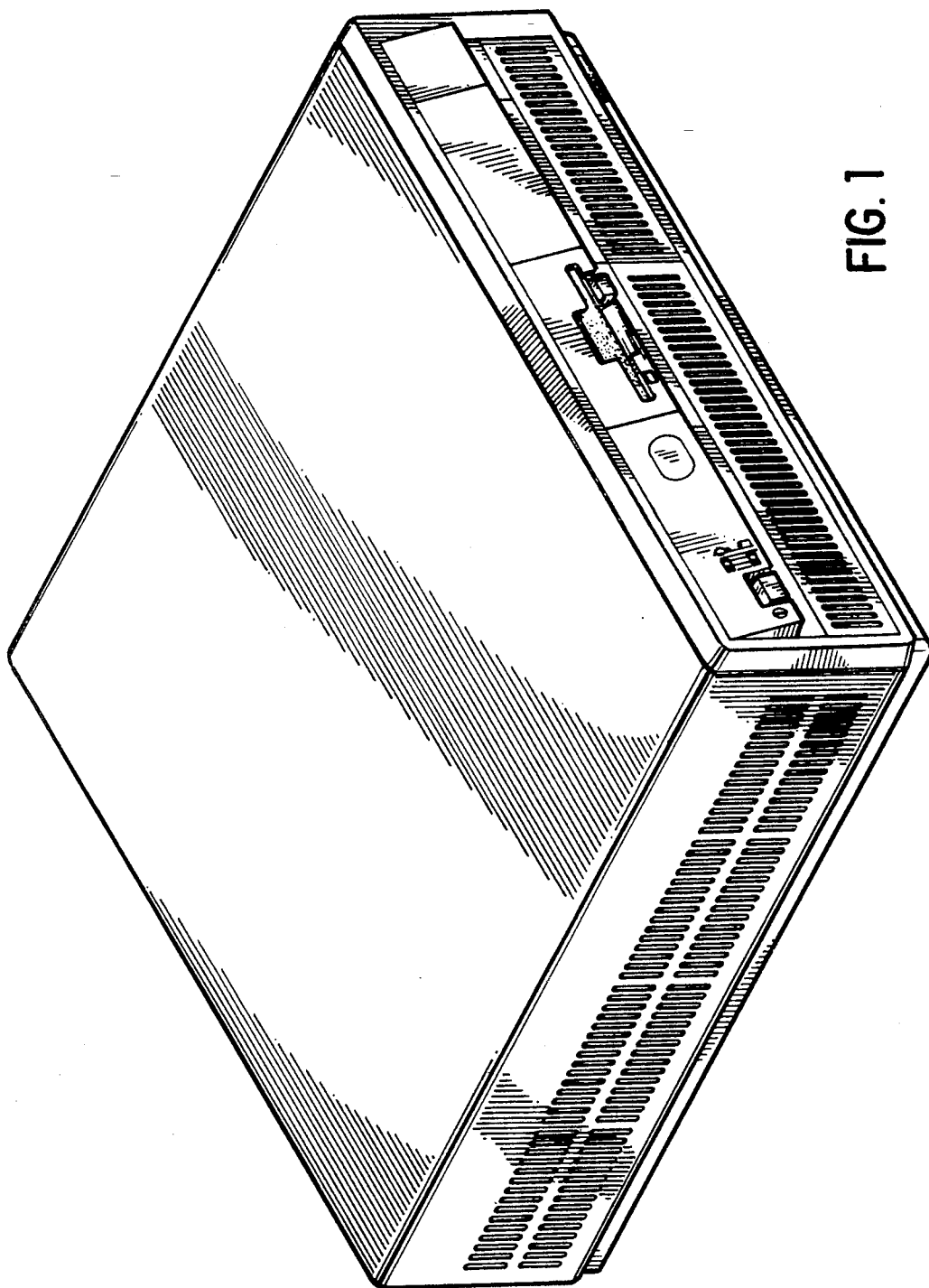

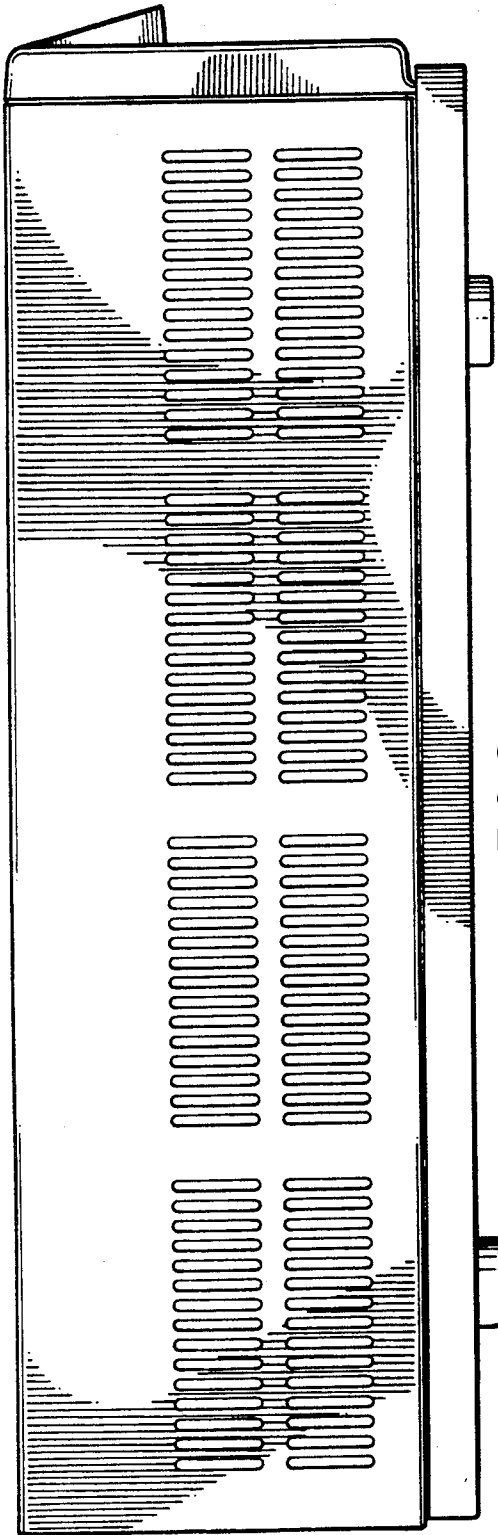

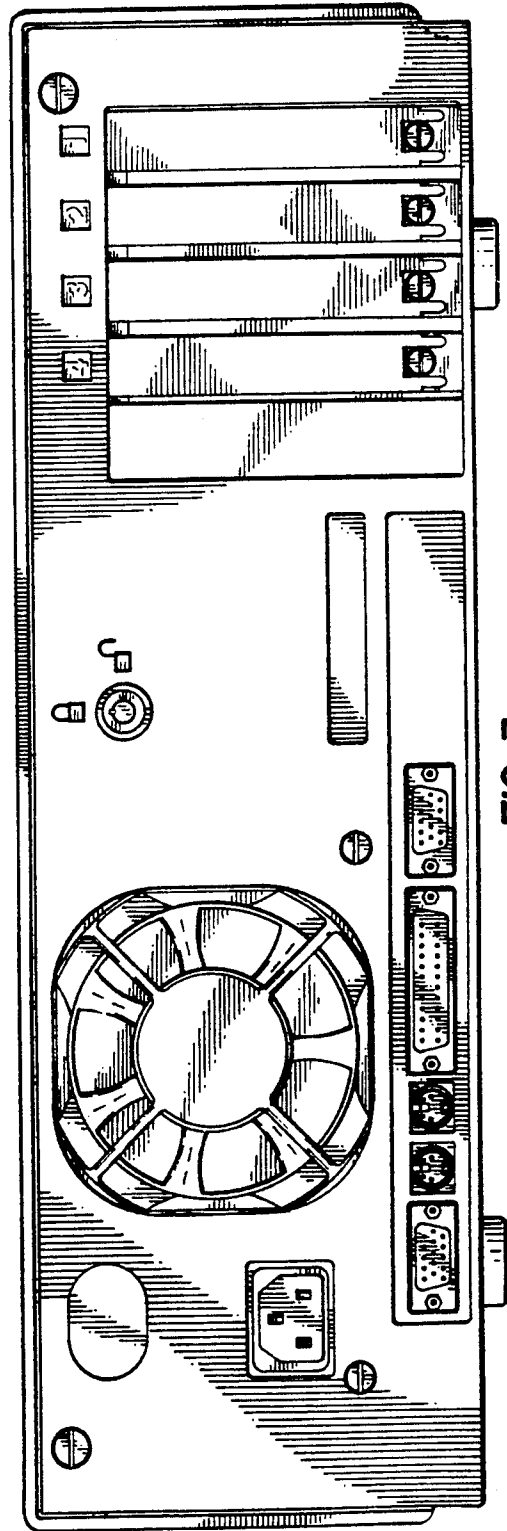

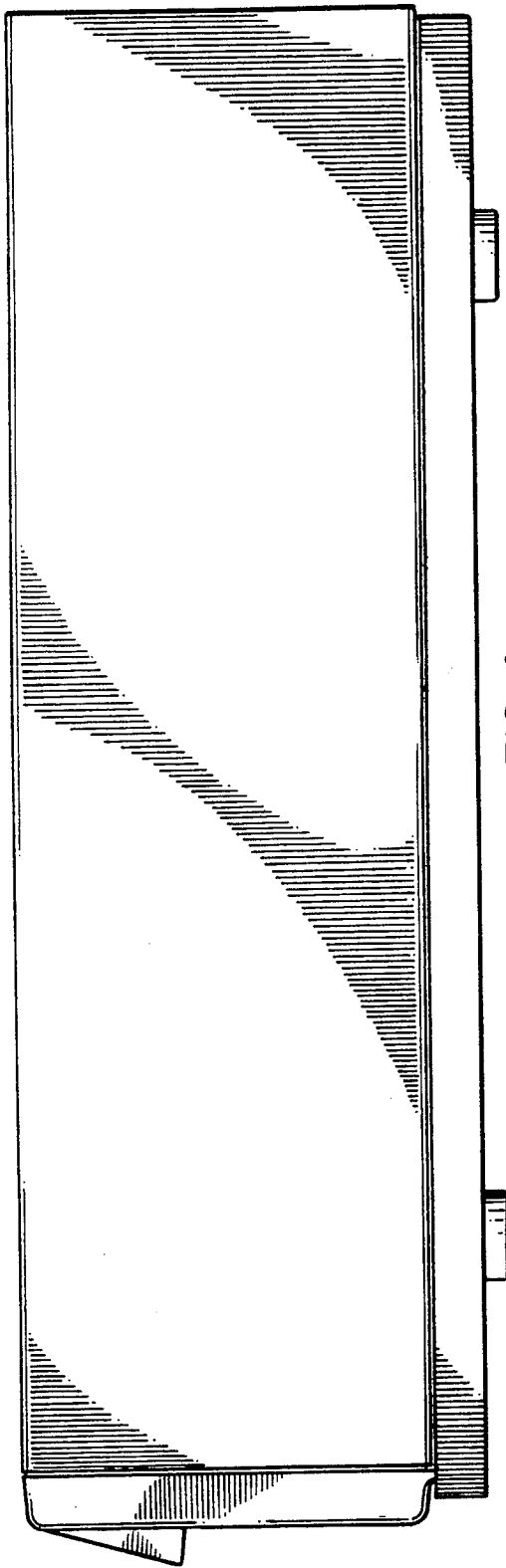

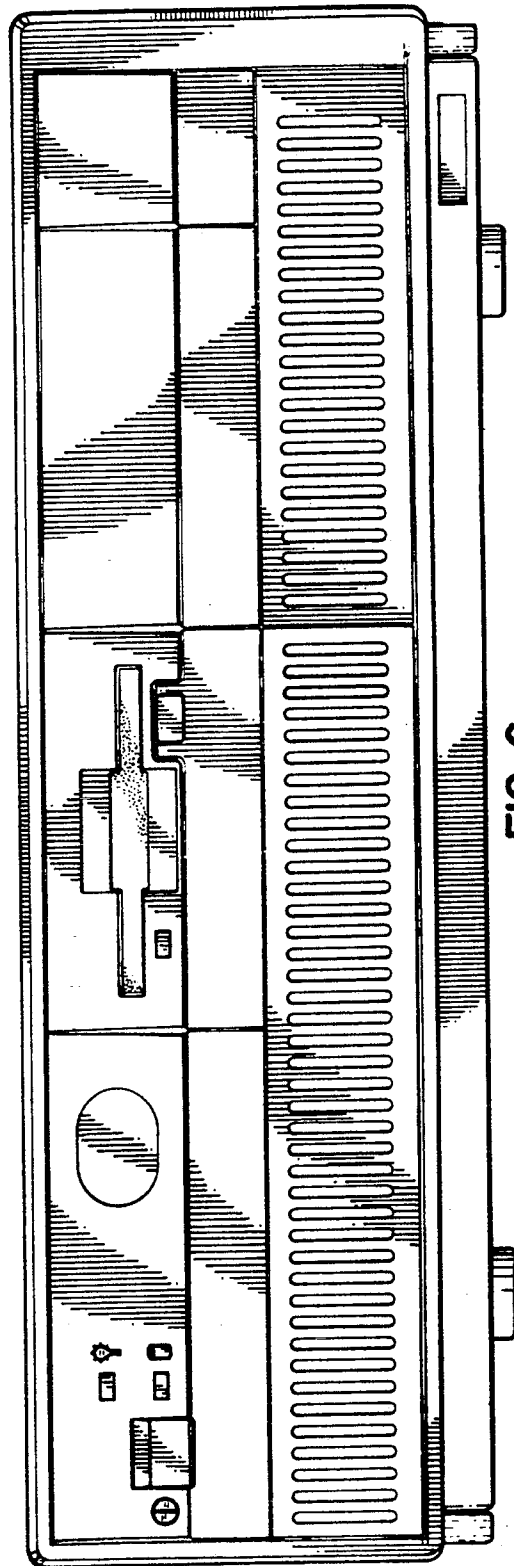

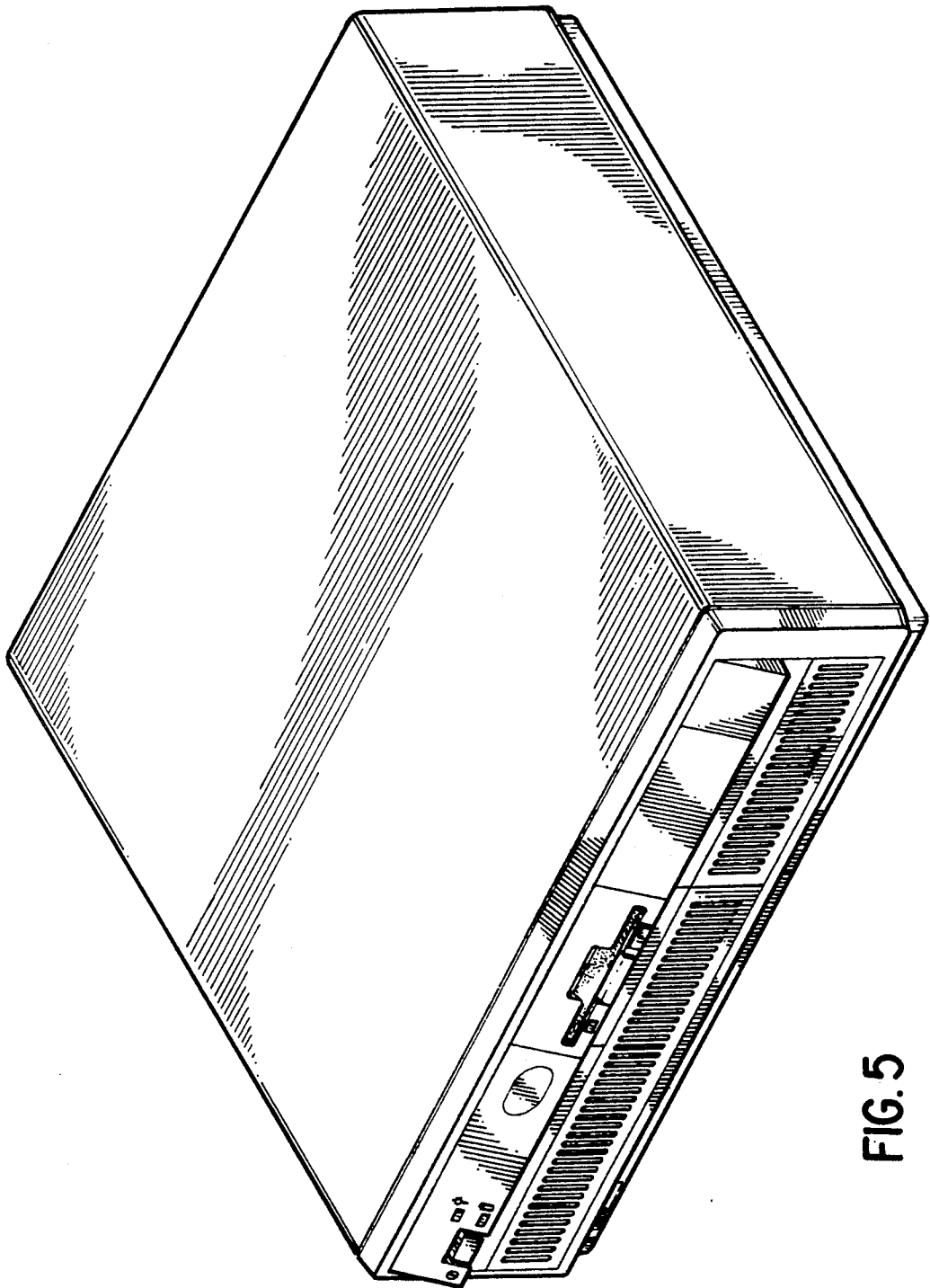

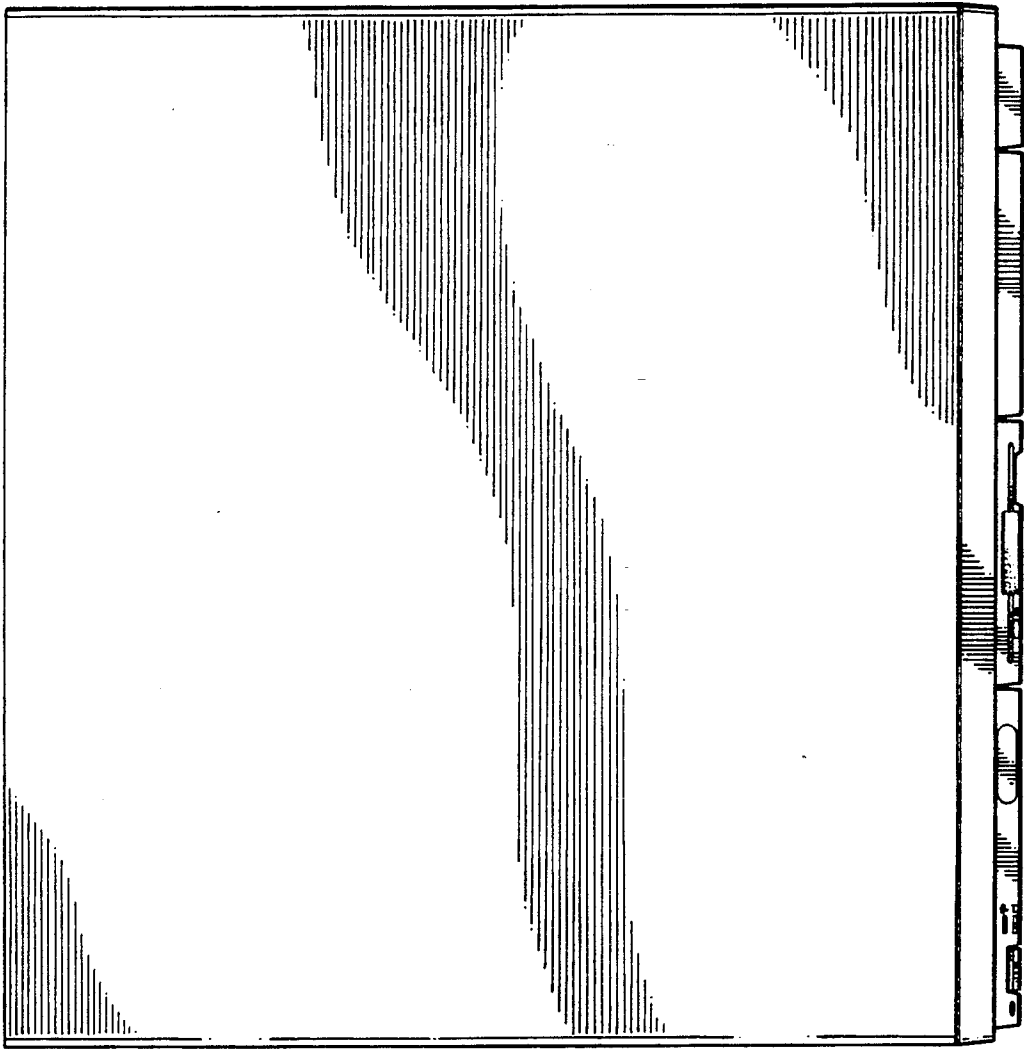
